**Action:** Richard Ackermann made a motion to accept the audit. Thomas Beringer seconded. Motion passed.

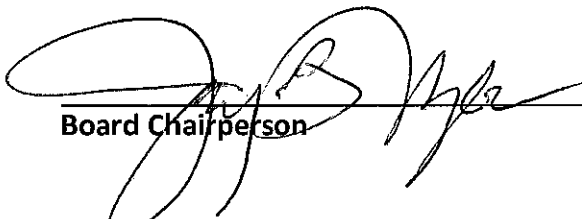
**Topic: KALBOH/NALBOH Update**

**Action:** No action needed.

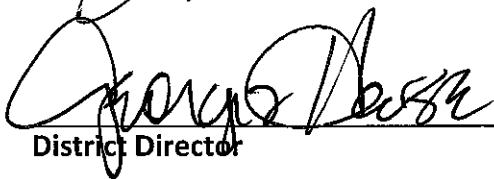
**Topic: Adjourn**
