Discussion: Dr. Heise discussed a hiring committee for the process of hiring a new Public Health Director for Three Rivers District.

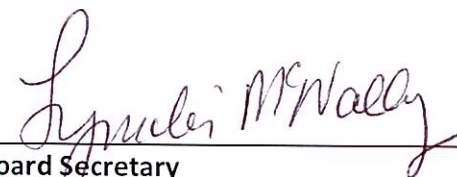
Action: No action taken.
